Notice Regarding Organizational Restructuring and Executive Officer Responsibilities

Kanematsu Corporation (“Kanematsu”) announces that at a meeting of the Board of Directors held on January 27, 2026, it resolved to implement the following changes to its organizational structure and executive officer responsibilities.

1. Organizational restructuring (effective April 1, 2026)

Through this restructuring, we aim to leverage the shared customer base of the Foods Division and Meat Products Division to strengthen our domestic and global marketing capabilities, thereby contributing to the expansion of value proposition and promotion of Groupwide management in line with our medium-term management plan, “integration 1.1.”

(1) Departmental restructuring

The Foods Division and Meat Products Division will be consolidated to form the Foods and Meat Products Division.
